LAFCO presentation Q & A: Christine Crawford from LAFCO gave an introduction into the role of the Local Agency Formation Commission (LAFCO) including our Sphere of Influence (SOI) Study that is completed every 5 years. There was discussion about the process, contents and purpose of the study. The study will be completed in the next two months with a draft copy available for comment then.

7. FINANCIAL REPORT:

- General Manager informed the board that Income is running slightly short. Could be because of people catching up from the holidays and some empty houses. Shut off list has had more people on it lately as well. Could still easily make up the difference. Expenses are running at about 50% of budget which is where we want to be. Have the paving job coming up soon. Money for that is set aside. Doing Three audits, only budgeted for one however we have been putting money away for the audits in prior years. Equipment rentals are high due to abnormal amount and significance of repairs lately. Utilities usually balance out.
- The monthly check to the county for December revenue will be \$20,403.98
- The monthly check to the county for January revenue will be \$21,169.62

- Park is in good shape staying on top of it.
- Well is working good. All the water tests have been good
- Gave update on building repairs.
- Audits have started for 2017, 2018 and 2019.
- Need to start working on budget for new fiscal year.
- Went to a training class on water tanks.
- Gave update on repairs completed and needed.
- Have not had a chance to work on enforcement policy.
