GM shared two letters from Yolo County regarding recent flood protection work and construction of a new culvert on Tutt street.

7. FINANCIAL REPORT:

- General Manager informed the board that the monthly check to the county for September revenue will be \$21,559.97 GM went over deposits and informed board the income is close to budgeted projections. GM explained to new Director how income is managed and dispersed to the County. The expenses have been a little tough because of repairs. Already hitting the budget hard. Repairs have been more expensive to complete than normal likely to go over budget. County and State permits have gone up.

Discussion: GM informed the board that only one person turned in an application for the vacant director position. A review of the application followed.

11. GENERAL MANAGERS REPORT

- Capacity at ponds is in good shape pond #4 and #2 dry. Ready for rains to hit. Need at least an initial rain before Yolo Flood can spray so that the herbicide will work properly. GM explained the relationship with Yolo Flood Control and their role in spraying at the ponds to the newly appointed Director. Access to ponds is still difficult at times because of the construction on SR16. GM has been notified by the State that they will be out in the near future to do an inspection of our facilities at the ponds.
- Park is good.
- Wells and everything else working well. The big sample test came back good.

- Having troubles with the account at 28824 Hurlbut. The Owner has had a balance for some time now and has not paid. Several repayment deals have been worked out for payment but none have been followed through on. Subsequently the owner rented out the dwelling. Tennant did not turn in service application given to them when they moved in November of 2018. The discrepancy was discovered in September of 2019. A shutoff notice was issued. Tennant never responded. Water was shut off. After a subsequent inspection it was noted the locking device for the shutoff had been tampered with and the water was turned back on. The service line was then excavated and the supply line severed after the property owner and tenant denied tampering with the shut off and turning the water back on. During excavation tennant became aggressive and threatening. This delayed completion of severing the service line. The Sherriff's dept was called out and the job to sever the supply line was completed.
- There have been many watermain breaks and they have been difficult and more challenging than normal. Have a few more coming up
- There have been several drainage and flood protection projects completed recently by Yolo Flood Control and Yolo County. Several years of work into getting these things done. More will be done and still needs to be done. Will also need to see how the current projects work and may need modifications.
- CAL Trans project Should be completed by the end of December. Traffic is still
 difficult. Once done it should overall be better. Been having to respond to several
 USA requests. Been very helpful now we are set up with USA 811. Also checking on
 the man holes and other infrastructure issues
- OES helped out by providing a generator during the PG&E planned power outage.
- Gave update on building repairs.
